- a. **Baker College** - Bentley will not participate in the CTE Program at this time due to lack of information
- b. **MVU** - We need to improve course options and the culture of learning. Currently we have eight students enrolled in MVP AP classes.
- c. **Lunch Charge Policy** - The potential lunch policy was reviewed by the Board. Mr. Arrington will work with Wayne Peter/NEOLA to create Board policy.
- d. **Bond/Facilities Update** - Mr. Costa will complete architect plans for the roof. Brett Stone made Mr. Arrington aware of the track not being up to code. Brett Stone will compile a list of what needs to be completed. The Board agreed that it needs to be brought up to code.
- e. **BOLD** – Mr. Arrington will investigate BOLD numbers to determine if we will continue with this program.
- f. **Bus Purchase** – We have money in the budget to purchase or lease a bus. Mr. Arrington will explore both options with the assistance of Mark Maloney.
